Dear Food Vendor:

Thank you for your interest in participating in the Millpond Music Festival. This is an outdoor festival held annually at the Millpond Recreation area, approximately 5 miles north of Bishop, CA, just off Highway 395. The 2018 festival will be held September 21<sup>st</sup> through 23<sup>rd</sup>.

Applications are due by August 10<sup>th</sup> and decisions will be made by August 17<sup>th</sup>, 2018.

Participants must supply their own display. Booth fees will be based on a commission rate of 15% of gross sales, to be paid by check (payable to ICA) or cash. We will provide you with an envelope for the fees, which must be given to an ICA staff person (to be specified) at the end of the festival. We do not require cash register receipts, our fees are collected on the "honor system." We trust our vendors to be honest and to pay the agreed upon fees. As you know, ICA is a non-profit community-based organization that works to bring quality arts programs to our community, including our schools. Fees paid by vendors help us to fulfill our mission – thank you!

Food vendors must provide a certificate of liability insurance with their application at least one week prior to the Festival and comply with all requirements of the Inyo County Environmental Health Department. The county inspector will visit your booth prior and during the show. You must enclose a \$25 check to cover inspection fee with your application (make check payable to ICA).

We are requesting that you provide us with 15 comped menu items. While we do provide backstage hospitality, we do not serve for as many hours as the vendors, and sometimes our food isn't ready before or after our artists perform on stage. We will prepare the 15 tickets and provide them to the artists.

All booths are required to be set up by 5 p.m. on Friday, September 21<sup>st</sup>. Each participant is responsible for the safety, protection and insurance of their own equipment. We do not guarantee protection against theft.

**You may bring vehicles to the food vendor area only during the following specified times, NO EXCEPTIONS:**

- Between 12:00 noon and 4:00 p.m. on Friday, September 21<sup>st</sup>
- After 11:00 p.m. on Friday, September 21<sup>st</sup>
- Between 7:00 and 11:00 a.m. on Saturday, September 22<sup>nd</sup>
- After 11:00 p.m. on Saturday, September 22<sup>nd</sup>
- Between 7:00 and 11:00 a.m. on Sunday, September 23<sup>rd</sup>

Please remember that **no dogs** are allowed in Millpond County Park.
