We will notify you of your entry upon approval.

BOOTHS: Booth spaces will measure 12 ft. x 12 ft. Booths will be spaced at least six feet apart. **You may apply for any or all of the Community Art Days, however priority will be given to vendors from the community in which each event is held.** Although participants must supply everything needed for their own display, the booth space is **free**. Electricity will not be available in your booth.

No Dogs allowed. Please leave your dogs at home.

Vendors must be set up by noon and are expected to stay until at least 6:00pm

Community Art Days - COVID 19 Guidelines

Per State of California mandate, **all members of the public and all workers are required to wear face masks**. ICA will provide each vendor with 5-10 facemasks for customers that may not have them. Vendors are required to ensure all customers wear a facemask.

A facemask is **required** when interacting in-person with any member of the public; working in any space visited by members of the public, regardless of whether anyone from the public is present at the time; and working in any space where food is prepared or packaged for sale or distribution to others.

Vendors & Artists

We ask that you please:

- Practice physical distancing with co-workers, fellow vendors, and customers.
- Mark out 6' of distance using visual cues. We will provide highly visible marking paint.
- Disinfect high traffic communal areas at least every hour.
- Wash hands frequently and as activities warrant.

Do not come to the events if you are exhibiting any of the following symptoms: fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, or diarrhea, OR if a worker was diagnosed with COVID-19 and has not yet been released from isolation, OR if, within the past 14 days, a worker has had contact with someone who has been diagnosed with COVID-19 and is considered potentially infectious (i.e. still on isolation). All vendors and their staff should perform daily self-screening, including temperature or symptom checks using CDC guidelines. In granting this full and complete release and waiver of liability, I specifically waive California Civil Code Section 1542, which states:

A general release does not extend to claims, which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him, must have materially affected his settlement with the debtor.

I expressly desire to release the County of Inyo and Inyo Council for the Arts, its employees, officers, agencies, volunteers, and officials from any financial responsibility to me for any personal injury and/or property damage I may incur, even when it results from the negligence, both active and passive, of the County of Inyo or Inyo Council for the Arts, and/or its employees.
